Dear Tribal Members,

On May 14, 2021, the Tribal Council requested American Rescue Plan Act (ARPA) funding from the U.S. Department of Treasury due to the crippling effects of the novel coronavirus on Klukwan. The Tribal Emergency Operations Center has been working diligently on a budget for ARPA funding to assist tribal members or residents of Klukwan. On October 13, 2021, the Tribal Council when on record to approve an initial amount of **\$2,000 per household** and an additional *\$100 per dependent*, for utility assistance, rent or mortgage assistance, and food assistance to alleviate ongoing effects of the novel coronavirus.

### **Eligibility Requirements:**

1. Must be an enrolled member of the Chilkat Indian Village that lives within the CIV service area (70-miles), OR
2. A resident of Klukwan; AND
3. Not receiving ARPA funding from another tribe.\*\*

\*\*Tribal members are still eligible if they have received assistance from Tlingit & Haida or Sealaska as they are regional entities.

### **Completing Your Application:**

- Completed applications must have account numbers for electric, water and sewer, internet, heating fuel, or propane.
- If you are requesting assistance with wood, you must contact the vendor prior to requesting wood assistance. List their name and contact information. All *new vendors* must fill out a W-9 before checks can be cut.
- If you are requesting rental assistance, please provide your landlords contact information. We may need to request a W-9 prior to making a payment.
